2. Treasurer Report

- Loss in 2019-2020 at about \$115k but partially due to accounting of fall fees from 2019 that went in 2018-2019 giving us a larger than normal profit last year. Real loss will end the year at about 70k. Approximately 480k in bank but \$145k appropriated to field and education costs.

3. Constitution

5. Fall Season, COVID impacts and Attestations/Documents

- Fall season options:
 - Option 1 - Start games as normal
 - Option 2 - Start games after Labor Day
 - Option 3 - Start after Oct. 4 and play 4-8 games
- US Club Soccer Passes:
 - US Club will not refund the cost of player passes if the season does not happen.
 - US Club recommended that you hold off on purchasing passes until about 10 days before the first game.
 - Note: current passes expire on 8/1/20 (therefore no secondary insurance if practicing, scrimmaging before new passes are approved)
 - Individual communities can decide whether to delay requesting passes to avoid non-refundable cost of passes or can request now so that players can be covered liability wise.

7. Scheduling

- Game scheduling is being put on hold until 8/2

8. Coaches Education

- No coaching education until Phase 3.
- Grassroots classes can be done in a 2/2 option. 2 hours in class and 2 hours outside.
- Players will not be used as demonstrators. Coaches will be the participants for field demonstrations.
- Blended virtual and in-person coaching courses will also be available soon.
- All virtual grassroots courses will be available in 2021.

9. Ohio Travel Cup

- By a show of hands, communities expressed interest in playing in the Ohio Travel Cup.
- Decision on going forward with planning of The Ohio Travel Cup is on hold right now

10. Fall Season Referees
